




Water Resources Development Act

- Modify the authorized project as recommended in the January 2014 Final Report ... by adding a pilot channel, riparian woody vegetation and slack water areas to restoration on Martinez Creek, along with a 5-acre wetland adjacent to Martinez Creek, in lieu of Alternative 6. This plan is referred to as Alternative 7 in the 2014 Final Report and included in the Section 7001 of the 2023 **Report to Congress on Future Water Resources** Development, dated February 2023.
- Requests submitted by Rep. Casar, Castro, Cuellar & Gonzales with a joint delegation letter



San Pedro Creek Culture Park Update

Phase 3: Alamo Street to Confluence w/ Apache Creek

- Paseos on either side of the railroad are nearing completion
- Collaboration with Union Pacific is on track
 - Pending final approvals for materials and construction plans
- On-site construction work around the bridge should begin in March
- Current completion date is set for September
- Completed installation of the El Paso Street Trailhead art piece










WSC ER: Predesign Activity Update

- All Pre-design surveys complete!
 - Topo, boundary, and Subsurface Utility Engineering (SUE) surveys accepted by USACE and shared with Design Team
- Geotech borings complete, under USACE review
- Request for Betterments/Additional Work under review by USACE
- Working towards 65% Design Review (Late Spring 2024)

USACE kicked off Cultural Resources survey, field work in progress




Michael Baker design team kicked off Subsurface Utility Engineering (SUE), Level B field work in progress






WSC ER: Schedule

• Design all 4 creeks together

- Spring 2023 \rightarrow Winter 2025
- Phased Construction
 - San Pedro and Apache:
 Winter 2025 → Winter 2027
 - Alazán and Martinez:
 - Winter 2027 \rightarrow Winter 2029



WSC ER: Apache Creek Remediation

- 40% Remediation design plans submitted in January
 - CoSA reviewing
- Construction solicitation est. January 2025

• Est. Start of Construction late Spring 2025
