





- The results of the River Authority's project will not be a part of USACE's Cultural Resources process, but will be integrated into other aspects of the project, such as the interpretive panels along the project



WSC ER: Schedule Update


65% Design on track for June 2024

 Project complete before start of Apache Restoration







THE NHPA AND THE GOAL OF THE SECTION 106 PROCESS

Of the multiple laws, regs, and E.Os passed to protect cultural resources, below is the primary driver for the USACE cultural resource program, as it pertains to the Westside Creeks Ecosystem Restoration Project:

National Historic Preservation Act of 1966 (as amended) and its implementing regulation 36 CFR Part 800.

- Section 106.
 - Area of Potential Effect (APE) and defined in 36 CFR 800.16(d): Area of potential effects means the
 geographic area or areas within which an undertaking may directly or indirectly cause alterations
 in the character or use of historic properties, if any such properties exist. The area of potential
 effects is influenced by the scale and nature of an undertaking and may be different for different
 kinds of effects caused by the undertaking.

Goal of the Section 106 Process:

It requires Federal agencies to take into account the effects of their undertakings on historic properties. The process seeks to accommodate historic preservation concerns with the needs of Federal undertakings through consultation among the agency official and other parties with an interest in the effects of the undertaking on historic properties. *For the Westside Creeks undertaking, identifying archaeology and architecture within the APE is the focus for the USACE.





ARCHITECTURAL SURVEY

Next Steps

- Once the USACE contractor has completed survey of the APE:
- 1. A draft report with recommendations of NRHP eligibility and effect is submitted to USACE for review
- 2. The USACE contractor makes edits to the 106-report based on USACE comments
- 3. The USACE makes a determination of effect for the undertaking (based on the contractor's recommendations) and the USACE also makes a determination of eligibility (if applicable) for any archaeological site, building, structure or object identified and recorded as part of the field survey
- 4. The USACE submits the draft report in consultation to the identified consulting parties for review and comment
- 5. The USACE contractor makes edits to the draft report based on comments received from consulting parties





6. Any collected artifacts are curated and the fully consulted on accepted final Section 106 report is filed with the Texas Historical Commission

*All steps of the Section 106 process are done in consultation with the identified consulting parties for this undertaking.
