





- Expected to be signed by the President soon




Local Construction Lead Update

- Progress on 1043(b) Application – Local Construction Lead (Non-Federal Implementation Pilot Program)
 - Section 1043(b) from Water Resources Development Act of 2014
 - Reauthorized in 2018, 2020, and 2024
 - New Implementation Guidance issued November 2025
 - Application completed over the holidays
 - Submitted to USACE on Friday, January 9, 2026
 - USACE has 90 days to respond

WSC ER: Design Activity Update

- Real Estate Acquisitions
 - All acquisitions are moving forward – **Target Summer 2026**
 - TxDOT
 - Support CoSA acquisition in TxDOT ROW
 - **Subject to USACE approval**
 - SAISD
 - Negotiating Purchase Agreement
 - Opportunity Home
 - Targeting BOD approval to submit HUD application in Feb
 - CoSA Coordination
 - Canvassing in progress

Apache Creek Remediation Update

- Contractor: [Summit Environmental Services LLC](#)
- Excavation **Completed Mid Dec.!**
 - All confirmation sampling completed
 - Bank reconstruction is nearly complete
 - Pulling sheet piles this week and next
 - **Next:** Topsoil/vegetation, haul road and temporary construction fence removal, permanent fence replaced
- Substantial Completion walk through targeted early February





Public Comment

- The following 7 topics were identified at the October meeting as potential subcommittee groups based on public comment and group discussion
 - Vehicular Trailheads
 - Security
 - Public Art
 - Public Transportation
 - Dog Parks (*significant discussion noted regarding concerns with locating dog parks near the creeks' watershed*)
 - Nuisance Flooding and Additional Flood Control
 - Community Education

Recommended Consolidated Subcommittees

- **1. Security and Safety**
- Security
 - Requests for increased Park Police presence
 - Requests for lighting along the trails
- **2. Public Art**
- Public Art
 - Requests for public art installations along the trails
- **3. Infrastructure and Accessibility**
- Public Transportation
 - Requests for public transportation access to the trail system
- Vehicular Trailheads
 - Requests for vehicular access to trailheads, including parking spaces
- Nuisance Flooding and Additional Flood Control
 - Street flooding concerns and requests for additional flood control improvements
- ***Community Education will be pursued by the entire WCROC***
